

TERMS AND CONDITIONS OF USE OF THE CONNECT WEBSITE

Welcome

Welcome to ConnecT Network ("ConnecT Network", "we", "us" or "our"). Thank you for using our website www.csur.ca and the other websites we own and operate (collectively, the "Website"). We hope you will easily find all the information you need.

Acceptance of terms of use

Please read the following stipulations carefully before using the website. Each time you access or use the Website, you enter in a contract with us and agree to be bound by these Terms of Use. If you do not agree to be bound by any of these Terms, you must not access or use this Web site.

Modifications

ConnecT Network reserves the right to make changes to these Terms of Use at any time. We will notify you by posting an update on the website. It is your responsibility to periodically review the Terms of Use. If you use the website after we have made changes, you accept the changes and agree to be bound by the Terms of Use as modified.

ConnecT Network also reserves the right to make changes to the website, including any products, goods, or services on or referenced by the website, or to discontinue access to the website, temporarily or permanently, with or without notice and without liability.

1) USE OF WEBSITE CONTENT

1.1 Responsibility of the User

As a User, you agree to use the Website diligently and responsibly and to comply with all applicable laws and standards as set forth in these Terms and ConnecT Network's Website Privacy and Security Policy, which is also available online on our website.

Each time you use the Website, you confirm that you agree to be bound, without limitation or qualification, by these Terms and you represent and warrant that you have the legal authority to agree to these Terms on behalf of yourself and any person you purport to represent. If you do not accept each of the provisions of these Terms of Use, if you are not authorized to accept these Terms or if you do not have the legal authority to accept these Terms, you are not authorized to access or use the Website.

1.2 Website access

Certain areas and elements of the Website are accessible only to users who have been issued a login and password by ConnecT Network. For example, as part of your registration to the Website for online purchases and sales, the user will choose a user code and password that will allow access. These codes are not known or

saved by ConnecT Network. These codes (user code and password) must be used in accordance with the present terms and conditions.

2) INTELLECTUAL PROPERTY

You may not freely and for any purpose use the content of the Website, which for the purposes of these Terms is defined as all content available on this Website including text, graphics, photographs, designs, graphical elements, headers, icons, presentation, arrangement, coordination sounds, data, images and enhancements, software, applications, audio and video clips and any other information included in the text and any other element available on or through the Web Site (the "Content").

In this respect, you are required to respect the following rights in particular:

2.1 Copyright

- 2.1.1 The Content belongs exclusively to ConnecT.
- 2.1.2 The Content, including compilations, selections, presentations, and arrangements of the Content are the exclusive property of the ConnecT Network Website or its assignees and are protected by national laws and international copyright conventions.
- 2.1.3 You may only use the Content for your own personal information. You may reproduce selected excerpts of the Content for strictly personal use if you maintain the intellectual property notices on the pages of the Réseau ConnecT website where the Content is accessible.
- 2.1.4 Any other form of use, in particular, reproduction, alteration, modification, distribution, transmission, republication, exhibition, broadcast, or public performance of the Content for any other purpose is strictly prohibited.
